Placement Assistance

Placement Assist is a screening service offered by FBFC Rescue to owners that would like to re home their dog(s) themselves with the benefit of FBFCR assistance. We feature their pet(s) on our page(s), provide guidance, applicant screening, home and reference checks and connect them with good match applicants. This helps to optimize the chance of finding a perfect forever family.

Biographical information relating to health concerns, history, temperament, needs, training and behaviour is provided by the owner. To be featured, dogs must be spayed or neutered, up to date on vaccines and vetting (proof required) and have no reported bite or aggression history.

NB: Placement assist dogs are not owned by or under the care or guarantee of FBFCR. Adoption contracts are between the owner and the adopter.

FBFCR requires a minimum donation of 50 dollars to help cover our feature and screening costs.

Adoption fees are required and are donated to FBFCR to help the dogs in Rescue Care

Though screening tries to match dog to adopter based on the dog's known nature, history, and needs, it is not always possible to predict how a dog will react or adjust in a new home or situation. Adoptive owners are strongly urged to exercise prudence, caution and patience when introducing an adopted French bulldog into a new situation until the dog has become fully adjusted to its new environment and the adoptive owner has had an opportunity to become familiar with the dog's unique personality. This takes time.

The French Bulldog Fanciers of Canada Rescue makes no claim, representations, or warranties regarding the temperament, behaviour, or future health of any Placement Assist dog

The following adoption contract is made between the owner of the dog named below and the adopter, whose signature also appears on this contract and who agrees to:

1. Provide this dog with personal I.D. tags, proper food, fresh water, and adequate shelter at all times.
2. Provide veterinary treatment for this dog as needed including annual examinations and appropriate vaccinations.
3. Comply with all local laws and ordinances relating to the keeping of this dog .
4. Notify the previous owner immediately if, for any reason, they are unable to keep this dog.

In signing this contract, I hereby accept possession of the French bulldog described below from the owner “as is” and at my own risk. I understand and acknowledge that the French Bulldog Fanciers of Canada Rescue has assisted with applicant screening only. FBFCR does not own nor have they ever had possession of this dog. I hereby release and waive any rights against the French Bulldog Fanciers of Canada Rescue, and any, and all, of their members or agents now or in the future for any damages to person or property caused by this dog.
